Information about the service

Service description

The Cloudification of work means that businesses need high bandwidth, high availability access to the Internet. *CommsChoice Enterprise Ethernet* (CommsChoice EE) is a high bandwidth, symmetrical access Internet service designed for business, enterprise and government customers. Once activated, CommsChoice EE delivers 50Mbps-1Gbps symmetrical speeds on NBN™ fibre infrastructure, depending on your chosen speed.

Service Availability

CommsChoice EE is available nationally within NBN's fixed line footprint. To improve availability of the service, NBN has simplified its fixed line footprint into four zones that can, at a high level, be defined as CBD, Metro and Outer Metro (Zone 1), Regional (Zone 2) and Rural (Zone 3).

Modem Charge

A modem is not included with this service. Modem charges will be determined by the modem chosen by the customer.

Minimum Term

All *CommsChoice EE* plans have a range of contract options including 12, 24 and 36-month terms. The agreement will specify the contract term.

Set Up Charges

12-month contract: \$5,000 setup (ex gst)

24-month contract: \$2,500 setup (ex gst)

36-month contract: \$0 setup

After the minimum term accounts will remain active on a month-to-month basis.

Class of Service (CoS)

There are two NBN access options for connecting to the Internet through CommsChoice Enterprise Ethernet; CoS Low and CoS High:

- **CoS-Low:** is ideal for best efforts applications like internet browsing. By default, all CommsChoice EE services are delivered on this CoS. Low CoS provides Peak Information Rate (PIR) up to the maximum bandwidth.
- **CoS-High:** used for time sensitive applications such as voice, video and Citrix (100% of the bandwidth is committed rate). This access provides no bandwidth guarantees on the internet service as your speed depends on a lot of other factors.

Installation charges

Standard installation is included at no charge with this plan. Installation charges may apply for non-standard installation. Any applicable installation charges will be confirmed prior to order acceptance and will form part of the contract agreement with CommsChoice.

CommsChoice EE is Price On Application (POA) as pricing is based on various factors including bandwidth, CoS, the Contract Term and the Zone of the location. All rates are ex GST unless otherwise specified.
